REGISTRATION

Memos will be circulated before a scheduled workshop with information on how to register - you will not be able to register before the memo is circulated.

CANCELLATION

Workshops may be cancelled at the discretion of the trainers due to lack of registrants. In the event of cancellation, all registrants will be notified <u>prior</u> to the event.

Emergency First Aid/Adult & Child CPR

(required within 60 days of commencement)

Emergency First Aid/CPR certification is valid for 3 years. All staff must maintain valid certification. It is your responsibility to ensure that you keep your required certificates up to date. There is no recertification for Emergency First Aid/CPR. You will need to re-take the whole one-day course every 3 years. Only staff who work in designated homes require annual CPR re-certification.

Medication Administration

(required within 60 days of commencement)

Medication Administration certification is valid for 3 years. All staff must maintain valid Medication Administration certification. It is your responsibility to ensure that you keep your certificate up to date. After the 3 years you will need to complete the training again.

The MANDT System®

(required within 60 days of commencement)

MANDT certification is valid for 3 years. All staff must maintain valid MANDT certification. It is your responsibility to ensure that you keep your certificate up to date. After the 3 years you will need to complete the full three-day training again.

Keeping People Safe From Abuse

(required within 90 days of commencement)

Keeping People Safe certification is valid for 3 years. All staff must maintain valid certification. It is your responsibility to ensure that you keep your certificate up to date. After 3 years you will need to complete the training again.
